Health Care Card Discount

The Catholic Education Commission of WA have amended the Health Care Card (HCC) discount offered to families holding a current means tested Health Care Card. The 2018 HCC student fee is \$300, inclusive of inclusive of all levies, amenities and other charges. It excludes users pay expenses such as Reading & Comprehension Book, Mathletics and Swimming lessons, fees for these items will be additional to the \$300. The sibling discount applies to the discounted rate as normal. The building levy for eligible HCC holders will also be reduced to \$90. Applications should be made through the office, holders of a means tested Centrelink Health Care Card, Pensioner Concession Card and (Blue) Department of Veterans Affairs Pensioner Concession cards are eligible.

Assistance with Fees and Payment by instalment

Payment Methods

Direct Debit – agreement will be sent with first term fees, can be set up as weekly, fortnightly monthly or quarterly.

Credit Card – either in person or by telephone

EFTPOS – in person at the office

BPay – our Biller Code and your account reference is at the bottom of the statement

Application Fee

All applications for enrolment of new students must be accompanied by a \$30 (GST inclusive) fee that is not refundable.

Enrolment Acceptance Fee

An enrolment deposit of \$100 (GST exempt) is payable on acceptance of a student's enrolment. This deposit is credited against the first terms fees once the student commences at the school.

Fees are payable within 28 days from the date of the account, unless a prior payment plan or Direct Debit payment plan is in place. Fees falling outside of these terms will incur an overdue administration fee of \$30.

Withdrawal of a student requires ten weeks' notice in writing. Where such notice is not provided the fees for one term are payable.
